Superintendent's Report

Employee Insurance Renewal

Todd made a motion to approve the renewal from USI which includes a 3.9% increase achieved through increasing the deductible by \$500 across the plans and adjustments to the prescription benefit, seconded by Sheppard. (Sheppard, Capps, Todd, York, Chapuis and Loveless voted yeah. Hill absent.)

Motion carried.

Bank of Louisiana Debit Card

The Bank of Louisiana presented the District a check for \$1,422.35 from the

first nine months of the program.

Lisa Traynor Contract

Capps made a motion to renew the contract with Lisa Traynor for the 2021-2022 school year, seconded by Sheppard. (Sheppard, Capps, Todd, York, Chapuis and Loveless voted yeah. Hill absent.) Motion carried.

Boiler/Piping at LES and electrical panel upgrade

Sheppard made a motion to accept bids from Sheet Metal Contractors, Inc. for the Elementary boiler and piping in the amount of \$158,600 and for the Elementary electric panel upgrade in the amount of \$13,820, seconded by York. (Capps, Todd, York, Chapuis, Sheppard and Loveless voted yeah. Hill absent.) Motion carried.

Door Bids

We opened a two week bidding period for the Elementary boiler/piping; door renovation around the District and HVAC for MS Library and Central Office. Bidders were hard to come by, people are booked for the Summer and have all they can handle. We only received one bid, and it was 25% higher than anticipated. FSG and Dr. Smith agree it will be more economical to re-bid it for next Summer or possibly over Christmas break.

Pepsi Contract

Capps made a motion to approve a new five year contract with Pepsi, seconded by Sheppard. (Todd, York, Chapuis, Sheppard, Capps and Loveless voted yeah. Hill absent.) Motion carried.

Additional Bond Projects

After the Meriwether demo our bond balance is \$600,000. Some additional projects we are planning: network upgrade (\$48,974); camera system upgrade (\$72,014); bus parking lot gravel/grade (\$15,500); upgrade radio system from analog to digital (approximately \$25,000). Capps made a motion to approve the QNS network upgrade and the camera system upgrade, seconded by Chapuis. (York, Chapuis, Sheppard, Capps, Todd and Loveless voted yeah. Hill absent.) Motion carried.

2020-2021 Budget

Dr. Smith informed the Board that a final amendment will be presented in June. The current carryover is \$32.13%.

2021-2022 Budget

Dr. Smith informed the Board that he has built next year's budget to include many of the discussion items tonight. He will make adjustments after the May meeting. He will bring a version for approval to the June meeting. The carryover is currently hovering around 32%. He has added in a line for five rooms of carpet.

New Mower Purchase

Todd made a motion to approve the purchase of a new Kubota mower from Meyer Implement in the amount of \$9,700, seconded by Capps. (York, Chapuis, Sheppard, Capps, Todd and Loveless voted yeah. Hill absent.) Motion carried.

Masks for Summer School

Sheppard made a motion to allow the mask mandate to expire at the end of the regular school year, seconded by York. (Chapuis, Sheppard, Capps, Todd, York and Loveless voted yeah. Hill absent.) Motion carried.
